The Evaluation Portal

Mosaic Network has partnered with CSSP to create a unique platform that integrates tools to support programs that are implementing the Strengthening Families Framework. These tools and our interdisciplinary approach will help you implement the Strengthening Families Framework into your program or system-level planning. In October 2014, Mosaic launched a re-designed evaluation portal in conjunction

with CSSP's introduction of four new program selfassessments. The system addresses the needs of programs, state or national leaders and evaluators working to promote stronger families.



Tools for Programs

Our evaluation portal

includes a number of tools to help programs assess their existing practice in the seven Strengthening Families program areas. As a program level user you will be able to enter assessments and run reports for your specific program.

- Program Self-Assessments (PSA)—guided surveys to help programs monitor their current work in the seven Strengthening Families program areas and identify small but significant changes they can make to enhance their ability to build protective factors.
- Protective Factors Survey (PFS) —developed by the FRIENDS National Resource Center, this survey measures changes in parental protective factors using a pre/post methodology. The evaluation portal supports programs in the confidential administration of the Protective Factors Survey.
- Staff Survey—developed through a collective effort of seven Strengthening Families states, this tool uses an embedded pre/post design to measure changes in staff attitudes, behavior and skills
- Integrated Action Planning—implement the Strengthening Families framework in alignment with QRIS ratings

 Reporting—create reports to view results on the assessments and also run data exports for further analysis

Tools for National and State Initiatives

As an agency that wants their programs to use the system as part of state or national initiatives like the QRIS, Child Welfare, Parents as Teachers etc., the system provides the administrative agency access to complete the program self-assessments and the related surveys. Additional consulting services, technical assistance and reporting options are available for multi-site implementations. Reports are available in aggregate form and for each program user.

- Grouping Programs

 — The SFEP provides the ability to
 put programs into multiple groupings (i.e., all programs
 in a state, participating in state/local initiative). It allows
 administrative users the ability to organize and manage the
 PSAs and results across all participating programs.
- Aggregate Reports—The SFEP provides an array of powerful reports for initiative leaders to allow them to view their results across all participating programs. Reports have built in filtering and customization options for easy access to critical information. If you are looking for more customized reporting, data integration and exports, SFEP provides access to many custom services for your agency's data and reporting needs.
- Expert Consultation—In addition to access to SFEP,
 Mosaic provides expert consulting to align a QRIS parent
 engagement component with the Protective Factors
 framework. Services include evaluation planning, research
 and design at the organization level. Also included are
 services relating to selection of evidence- based data
 collection procedures and assessment tools.
- Data Exports—SFEP allows researchers to export nonconfidential raw data to perform custom analysis and reporting.



The SFEP System Features

Strengthening Families Evaluation Portal comes pre-loaded with an extensive library of features for many types of users. The SFEP infrastructure has been designed with maximum flexibility and adaptability for a variety of program needs.

Personalized Dashboards

When users log into the SFEP, they are greeted with a custom dashboard highlighting the most relevant information per their needs. Dashboards may contain charts, graphs, quick links, messages, reminders, and to-do lists.

Easy Data Entry and Management

SFEP allows users to easily navigate and enter data on program self-assessments, staff and protective factor surveys. It allows for quick and easy results tracking for programs, states or regions. Each record's related information is viewable from one screen, providing a bird's eye view of program data.

Data Reporting

SFEP contains a powerful reporting engine that provides instant results for all stakeholders. Users are able to generate reports using real-time data, alerting them to adjust any data inconsistencies and enabling them to conduct self-evaluation. No additional software is required to run SFEP reports. Reports can be exported or saved as MS Word or Excel files.

Data Analysis

SFEP also provides options for data analysis to manage results, as well as consulting options for development of program improvement action plans. It allows for the performance of a wide spectrum of data analysis procedures, including both formative (process) and summative (outcome). Mosaic's extensive staff knowledge and experience working with quantitative and qualitative

data; from program-level to initiative-level, can help your program or initiative plan for improved results. Data integration services are also available to connect data from other data sources to the SFEP.
